(as applicable from 01st January 2020 for every author whether you submitted the
manuscript earlier or you are going to submit now)**

1. Authors should submit their manuscripts along with copyright form online at our website: <https://www.worldresearchersassociations.com/>

Copyright form should be sealed and signed by the corresponding author and it can be downloaded from the link: <https://www.worldresearchersassociations.com/forms/copyright.pdf>

After submission, all the copyrights will be ours but in case the manuscript is rejected or if the author is permitted to withdraw, the copyrights will be of authors.

2. There are no charges for submission, acceptance and publication of manuscripts in any of our journals in normal routine. Publication totally depends upon quality, originality and merits of the manuscript.

When authors get acceptance letters, there may be some revisions which authors have to do themselves. Further reviewers find that references are not up to the mark. Please follow our policy, style and format while checking for references. References should be checked and revised by authors as they know the source of reference as well.

(a) We charge only when the authors are in a hurry for thesis submission or promotion interview and they want fast or early review and publication for some reason or other. If you wish to go for an early or fast track, please submit the manuscript and copyright form first and then pay as per our policy immediately within a day or two. Please remember that review takes 60 days in routine without any payment and it takes 30 days for review if one opts for a fast track. We have a good number of manuscripts and we have a long queue. Our rejection rate is about 40 %. We accept plagiarism only up to 10 %. It takes 6 to 8 months for publication in routine after acceptance of manuscript and we are trying our best to minimize this period. It takes two to three months for publication on a fast track after acceptance of manuscript.

(b) We charge very nominal fees for language improvement nowadays. In most of the cases we have observed that language, spellings and punctuation are not up to the mark required for our journals. We were not charging language improvement fees right from the date of publication till May 2021. But because of Covid, we are overburdened and our team members who are efficient in language improvement have left us. Furthermore, the manuscripts we are receiving are very poor in English language. Punctuations, even full stops are missing everywhere. Spellings are also not up to the mark. We are informing the corresponding authors about language improvement if required, well in time before publication. Manuscript poor in language cannot be published. Therefore, either the authors should improve the language at their own end or we will get it done through Professions by charging nominal fees from you. Please note that language improvement does not mean references corrections by our team members. References should be checked by the authors themselves as per our policy.

(c) We also charge when authors wish to withdraw suddenly by cheating us because they have submitted the same manuscript to other journals without any information to us and if those manuscripts got published elsewhere, they ask us to permit the withdrawal of their manuscripts from our journals on one reason or other by deceiving us and not following international standards. Before submitting, authors are requested to get all the information at the website and in case they still want to withdraw, they will be allowed to withdraw within 7 days of submission without any payment. Manuscripts are sent to two peer reviewers within a week and so after that withdrawal is not possible and one has to follow our withdrawal policy. Withdrawal charges have

been put so that authors do not repeat such unethical practices again and again with any of the journals in the world.

Note: Corresponding author should be marked by an asterisk. Surnames or family names of authors will come first followed by initials or full names.

Here in a small section or paragraph, details of all the authors, their emails and mobile numbers should be given. If the author is a student, please mention a research scholar or M.Sc. student or M. Tech student or so. We discourage M.Sc. or M. Tech students until they are in the field of research. Please produce his or her latest proof of identity in case of students from the Registrar of University or Principal / Director of the College.

Please see that the number of authors does not exceed five. If there are more than five authors, please justify. We have found that corresponding authors just add many authors to give them an advantage of publication whereas those authors have not done any research. In some cases, we even found that such authors even did not belong to relevant fields. If there are 10 or 20 authors and if all have contributed to research, we will include all the 10 or 20 authors but there should be a validation from the corresponding or main author that all were involved in the research.

As our main aim is to promote research as well as researchers, we do not take any charges towards acceptance or publication. We prefer that research students, scientists and academicians from all parts of the world submit their manuscripts to us. Normally we see that the same author or the same authors send us more than three manuscripts, say even 5 to 6 manuscripts in a year and that reflects sometimes on the quality of the research

papers as well. If we publish more than three manuscripts the same year, we are not able to justify our aim to promote the research and different researchers. Therefore, we restrict the submission of the number of manuscripts to three including all our journals by the same author or authors in a year in the normal routine. Exception is only for annual and fellow members.

6. The manuscript should be divided into Abstract, Keywords, Introduction, Material and Methods, Results and Discussion, Conclusion, Acknowledgement and References. For more details, please go to instructions to authors (Link : <https://www.worldresearchersassociations.com/instoauthor.aspx>) under our policies or go to the current issue of the journal. References should be serially numbered and they should be in alphabetical order as per surnames or family names. In the text as well, please quote reference number, not the author name and year. For example

But "Examples are copper (Cu), lead (Pb), nickel (Ni), cadmium (Cd), mercury (Hg), arsenic (As), zinc (Zn) and chromium (Cr).^{10,7,6} It is not as per our policy. Or

"Examples are copper (Cu), lead (Pb), nickel (Ni), cadmium (Cd), mercury (Hg), arsenic (As), zinc (Zn) and chromium (Cr) (Changfeng 2019, Huang 2010, Chileshe et al 2020). It is not as per our reference policy.

"In recent studies of Bat et al², it has been observed that mangroves play an important role." is correct.

But we do not prefer

"In recent studies of Bat et al., it has been observed that mangroves play an important role²."
